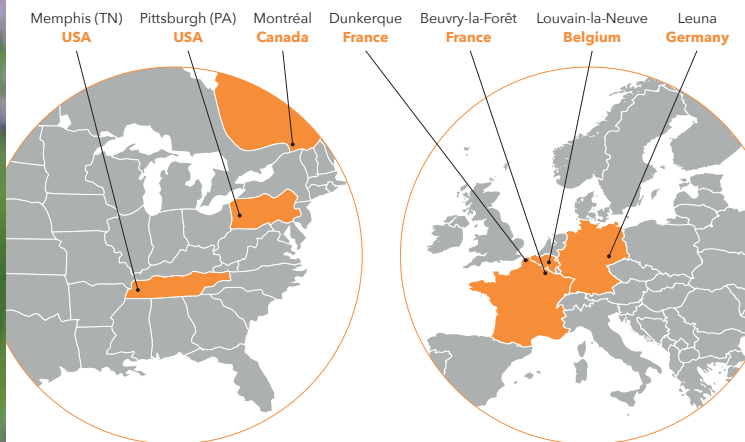

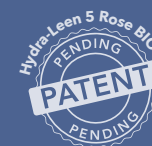

Non-stabilized hydrolats are quite **fragile products** that are sensitive to microbial contamination and can degrade over time. They must normally be stored in closed containers under cool and controlled conditions. Some non-stabilized hydrolats may even phase-separate, especially when stored in cold temperatures.

In contrast, thanks to our unique technology, the **Hydra-Leen** range of hydrolats from MINASOLVE is optimized for a **homogeneous composition** and an **extended shelf-life of 24 months**, even when **stored at ambient temperature** or **transported in hot or cold climates**. **Hydra-Leens** are free of listed preservatives, produced from **ORGANIC plants** and **COSMOS Certified**.

All hydrolats used in **Hydra-Leen** are produced by our neighboring partners who maintain a **close relationship with the farmers** and guarantee **full traceability of the ingredients**.
